## NOTICE TO EXHIBITORS

### DOGS ELIGIBLE TO ENTER THE AKC FETCH TEST

- The test is open to all dogs at least 6 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or dogs enrolled in the AKC Canine Partner Program.
- Females in season may enter. They will run at the end of each event. They should wear panties to prevent soiling the test area.
- they display no signs of physical discomfort and can safely complete the test.

- Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, Dogs with bandages, sutures, or visible wounds are not eligible to compete.
- Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test and the dog does not appear to be under undue stress in the opinion of the judge.
- Dogs may wear slip collars, buckle collars, martingales at the test and on the grounds. They may not wear prong collars, e-collars, head collars, muzzles or body harnesses on the grounds.
- Leashes need to be 4 to 6 feet in length, no flexi leads allowed.
- EXHIBITORS MUST be governed by any rules and regulations of Petrack Park and/or local restrictions. All dogs present must be on leash or confined except when being judged. Failure to comply will result in charges being brought before the Event Committee. The Event Committee reserves the right to make such other regulations as they may deem necessary (not to conflict with the AKC rules) on the day of the events.
- Pahrump Valley Obedience Club of Nevada Inc., Officers, Trial Secretary, their agents, employees etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property whether the result of accident or other cause and further assume no responsibility for injury to children. - Retrieving dumbbells or gloves are not allowed in FETCH Test.
