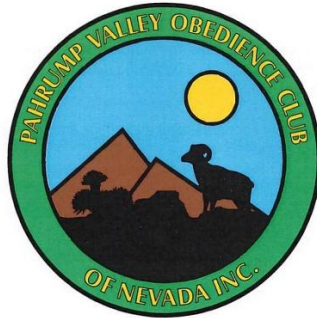

**ATT TEST - REGISTRATION – EVALUATION FEE:**

**Twenty-Five Dollars (\$25.00) per dog, per test/event entered.**

**(Registration Fees to be paid in cash or by check only – NO credit or debit cards accepted.)**

**Day of Event Registration/Entries only – No Pre Registration/Entries Accepted.**

Each testing event has a limited entry of 50 dogs/evaluations per event.

Dogs can only be entered once in a single event and may be entered in both events.

To apply and obtain an AKC Temperament Testing Title, Dogs must pass the testing twice under different evaluators.

**Returned Checks** – The Pahrump Valley Obedience Club will add a collection fee of \$35.00 to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis for any event sponsored by the Pahrump Valley Obedience Club of Nevada.

**Awards and Prizes**

A Ribbon will be awarded to each dog passing the AKC Temperament Test at each event.
